The easiest way to renew your membership is **ONLINE** at www.fsoc.co.uk. Hover over Membership and click Membership Renewals. Scroll down past the Register button to the bottom and click on Membership Renewal. This takes you into the Crossmember system. Enter your membership number or surname. When your details come up click on View. Check your details are correct and then click on Renew Membership. Click on PayPal/Card, agree to the data statement and click Save. This takes you into PayPal where you can make your payment. **Please use this online service if you wish to pay with a Credit or Debit card.**

BY POST: If you do not wish to use the online service then please complete the following sections, returning to the Membership Secretary (address below overleaf) together with your cheque payable to **Ford Sidevalve Owners' Club Ltd** for the appropriate amount. **Our bank will reject cheques made out to FSOC.**
